Prospectus

A. Introduction

The ANSN Education and Training Topical Group meets annually in order to identify, amongst others, training activities of interest for the region. In 2014 the ETTG met in Vienna and recommended a number of regional activities in the area of training. Amongst these activities, one of the ETTG representatives from Japan offered to make the necessary arrangement for Japan to host a regional workshop on “Instructors Training Programme”. This regional workshop was approved by the ANSN Steering Committee.

B. Objectives

The objective of this regional workshop is to provide instructors with information on the subject of “Safety Leadership”. It will address amongst others, IAEA safety standards and the concepts of leadership, management for safety, and safety culture for the regulatory body and other stakeholders involved in the implementation of a nuclear power program. Lessons learned from past nuclear accidents and regulatory enhancements will also be lectured. The workshop will offer opportunity to share experiences, training strategies, and relevant ANSN and IAEA materials.

C. Target Audience

Candidates should be professional staff members of regulatory bodies, technical support organisation, operators, research institutions, hospitals or schools, which hold a degree in science, engineering, medicine or education.

Participants are expected to be conversant with the IAEA Safety Standards, prior to the workshop

D. Working Language

The working language of the workshop will be English.

E. Structure

The regional workshop will consist of lectures based on Japanese experience, discussions and technical visits. The IAEA shall provide relevant training materials and tools in line with the IAEA safety standards as well as an expert to present international perspectives. The training materials used in the workshop will be shared among the participants.

F. Application Procedure

Prospective participants should first apply through the ANSN website (<https://ansn.iaea.org>). If requested by the national authorities, the completed Nomination Forms should then be endorsed by these and returned through the established official channels (e.g. Ministry of Foreign Affairs, National Atomic Energy Authority, or office of the United Nations Development Programme). They must be received at the IAEA, Vienna International Centre, PO Box 100, 1400 Vienna, Austria, not later than **31st January 2018**. Nominations received after that date or applications which have not been routed through one of the aforementioned channels cannot be considered.

Nominating governments will be informed in due course of the names of the selected candidates and will at that time be given full details on the procedures to be followed with regard to administrative and financial matters.

H. Venue

The workshop will be held at the Wakasa Wan Energy Research Center, Fukui, Japan.
